
Step one



Begin Application and Check Eligibility

Verify if your business meets the minimum criteria:

- limited company registered at Companies House,
- trading for at least one year,
- Annual revenue over £50,000
- positive Net Tangible Asset position,
- no outstanding CCJs; and
- not operating in prohibited industries.

Step two



Indicative Credit Limit Confirmation

If the customer passes the initial criteria, the introducer can either progress the application or request a callback to discuss further.

Once the the introducer approves the credit limit, the customer receives a confirmation email, allowing the customer to progress their application.




Step three



Company Information

Complete a short company questionnaire and add director and shareholder information.

The customer will then be prompted to provide consent to Open Banking.



Step four



Credit Assessment

In-line with Know-Your-Business (KYB) regulations, multifi then undertakes a company background and credit assessment check which typically takes 72 hours.

In some instances a face-toface call may be required at this stage.



Step five



Director and Shareholder Checks

After a customer successfully passes the credit assessment all directors and shareholders will receive a notification to upload identification as part of (Know-Your-Customer) regulations.



Step six



Contract

When all checks are complete a contract is sent to the customer along with a credit agreement and product pack.

Minimum Transaction Size	£20
Maximum Transaction Term	The Customer can submit a Repayment Request on the Multifi Platform in respect of the whole or part of any amount owing to the Platform Lender at any time up to 120 days after a Transaction is made (such date, the "Maximum Term Date" as referenced in the Services Terms). Upon receipt of a Repayment Request, funds will automatically be debited from the Customer's E-Money Business Account provided by Multifi.
	If there is an outstanding balance due to the Platform Lender in connection with any Transaction on the Maximum Term Date, such outstanding amount will automatically be debited from the Customer's E-Money Current Account provided by Multifi and paid to the Platform Lender.



Onboarding


When the contract has been signed a member of the multifi team will schedule an onboarding call for the platform.


